SUBJECT: House Bill 166/ORC 121.95 Rule Provisions

The Department of Public Safety is submitting the initial base inventory of rules required by Section 121.95 of the Ohio Revised Code as enacted by House Bill 166 of the 133rd General Assembly. Included in this memo is a consolidated spreadsheet showing the breakdown of rules and restrictions by chapter. The full inventory spreadsheets are included as attachments.
